#### m. Electronic books

Electronic books are cited like their print counterparts; in addition, you will need to include information about the format consulted. For resources accessed through Logos, add Logos Bible Software to the end of the citation. If the book was read online, include both an access date and a DOI, URL, or database name. (See example n. for more information about citing electronic works.)

If no real page number is available, use other identifying information, such as chapter (chap.), part (pt.), or section (sec.) headings. See examples below.

## n. An internet publication with a print counterpart and publications accessed through a commercial database (such as through Miller Library)

A journal article with a print counterpart accessed online (or through an online database) is cited in the same fashion as its print counterpart, with access information added to the end of the citation. According to Turabian, "If such a database lists a recommended URL [i.e. a shortened URL] along with the source, use that one instead of the one in your address bar. A URL based on a DOI [Digital Object Identifier], if available, is the best option...if no suitably short and direct URL exists, however, you may substitute the name of the database for the URL (e.g. LexisNexis Academic)" (p. 141). See Turabian 15.4.1 and 17.2 for additional information.

# o. Websites and internet publications without a print counterpart (i.e. available online only)

For original content from online sources other than books or periodicals, include as much of the following as you can determine: author, title of the page, title or owner of the site, and publication or revision date. Also include an access date and a URL.

#### p. One source quoted in another

As noted in Turabian (8th ed.): "Responsible researchers avoid repeating quotations that they have not actually seen in the original. If one sources includes a useful quotation from another source, readers expect you to obtain the original to verify not only that the quotation is accurate but also that it fairly represents what the original meant.

If the original is unavailable, however, cite it as 'quoted in' the secondary source in your note. For the bibliography entry, adapt the 'quoted in' format as needed' (p. 215)
